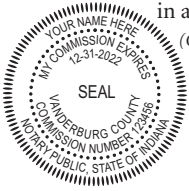


Round Self-Inking Stamp

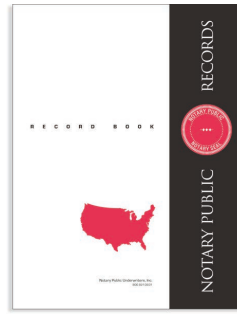
Round State Approved Notary Stamp - not actual size.

Maintaining a record book is not required by Indiana law, but it is recommended by the Secretary of State.

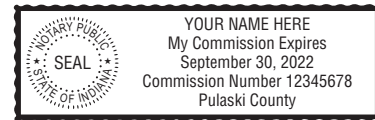

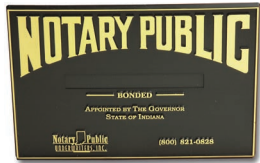

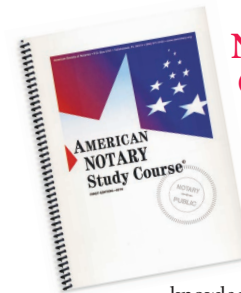

Consider these Actual Cases:

- A property owner and a bank sued a Notary. She did nothing wrong, but was deceived by identity thieves. The Notary chose to pay to settle both lawsuits rather than endure prolonged litigation. *An Errors & Omissions policy would have protected her.*
- A Notary witnessed the signature of a minor on a deed transfer, using a passport as identification. When the parents divorced, the Notary was sued on behalf of the child by her legal guardian.
